Interested Consultants/Firms should provide a brief expression of interest demonstrating that they have the required qualifications and illustrating that they have the relevant experience, staff and financial capacity to perform the Services.

The following evaluation criteria will be applied when short-listing Consultants:

- a. Profile of the Firm/Core business and company's establishment demonstrating specialization in wetlands rehabilitation, urban flood management or urban landscaping
- b. Firm's eligibility supporting documents and brochures; (Both Soft and Hard copies are required).
- c. General experience of the firm in the field of wetlands rehabilitation, urban flood management or urban landscaping.
- d. List and Description of similar assignments undertaken by the firm in the past;

- f. Availability and Summary of qualification and experience of key staff;

## **Expected time schedule of Supervision Firm**

The overall assignment of supervising in all five wetlands are expected to be completed in 30 months. Actual supervision is however expected to be undertaken over a 24-month period.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016. ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest. A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
